## SYNtrac® Scheduling System (HL7) Interface

### System requirements

You will need to be upgraded to the latest SYNtrac® version to use the interface. We also require participation from your Information technology group, to confirm the system is Health Level Seven (HL7) compliant and to provide a sample message that will be sent from the customer system to your SYNtrac® system.

### SYNtrac®-to-CardioWriter™ Interface

The SYNtrac®-to-CardioWriter™ Interface sends scheduling, patient and dosing data from SYNtrac® to CardioWriter™ automatically as cardiology patient procedures are completed. This solution will assist your department by eliminating duplicate entry and keying errors in SYNtrac® and CardioWriter™, which saves staff rekeying time.

This interface allows for the transfer of patient scheduling and dosing information including the following:

- date
- time
- MRN
- study schedule
- first and last name
